Rule 11 1 of the Beijing Rules provides that whenever appropriate, consideration shall be given 2d dealing with child offenders without resorting to formal trial by the competent authority. Where the court directs incarceration, he should affirmatively find upon the record either that the child's behavioral problem is not the result of social conditions beyond the child's control, 2d rather of an intentional failure on the part of the child to conform his actions to the law, or that the child will be dangerous if any other disposition is used, or that the child will not cooperate with any rehabilitative program absent physical restraint.
